Sealed bids will **ONLY** be received and accepted via the online electronic bid service through www.questcdn.com until **9/14/2023 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

An east-west alley in the Pettit-Rudisill Neighborhood Association bounded by Milton St. to the south, Baxter St. to the north, South Park Dr. to the west and Smith St. to the east. The existing 10' wide concrete alley and approaches will be removed and replaced with an 11' wide concrete alley, new concrete approaches at S. Park Dr. and Smith St. and minor residential drive approaches where needed. Minor stormwater adjustments along with curb and parkstrip restoration are included with this project as well.

All in accordance with the Bidding Documents and Drawing No. ST- **0598D** as prepared by **Transportation Engineering** for the City of Fort Wayne, Indiana.

No bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City, upon any debt or contract, or who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City.
