The funding source for this project is WATER UTILITY REVENUE (SRF).

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Adams Center Road & Tillman Road Water Main Extension as follows:

Installation of 13,200' of 24" and 8,000' of 16" HDPE pipe by horizontal directional drilling along with hydrants, valves, and all other appurtenances.
