The funding source for this project is SEWER SRF.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Foster Park Relief Sewer - Hartman Road DS01 to CSO 20 as follows:

Installation of approximately 3,100 LF of 72" and elliptical relief sewer and associated structures installed via open cut installation. Work includes 2 diversion structures and associated appurtenances including hatches, adjustable weirs, slide gate, communication conduit and floatables control.
