The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Cherry Hill Lift Station Improvements as follows:

Improvements to Cherry Hill Lift Station include removing existing equipment, and installing sanitary manhole, bypass tee, new sewer pumps, valves, piping, hatch, controls, and telemetry.

Berry St Fort Wayne, IN or via Zoom to familiarize prospective bidders with the proposed project and to answer any questions. There will also be an online meeting at the same time.
