The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Construction of 10' wide multi-use asphalt trail along south side of St. Joe Center Road from Chiswell Run to Meijer Drive, and along west side of Wheelock Road from St. Joe Center Road to southern approach of Jefferson Middle School with ADA ramps, pedestrian crossings, drainage accommodations and restoration

all in accordance with the Bidding Documents and Drawing No. ST- **0183N** as prepared by **DLZ Indiana** for the City of Fort Wayne, Indiana.
