Sealed bids will ONLY be received and accepted via the online electronic bid service through www.questcdn.com until **1/30/2020 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

That it is deemed necessary to improve: Washington Center Road by constructing a 5 foot wide concrete sidewalk along the north side of the road to fill in existing sidewalk gaps beginning 60 feet east of the former Grand Rapids Indiana Railroad corridor to 400 feet west of Lima Road. The project includes a retaining wall, ADA curb ramps, accessible pedestrian signals at Cross Creek Boulevard, pavement markings and erosion control measures.
