Sealed bids will ONLY be received and accepted via the online electronic bid service through www.questcdn.com until **3/19/2020 at 2:00 pm** and publicly opened at Citizens Square, 200 East Berry St, Fort Wayne In, Public Works Office, Suite 210, in Conference Room 220.

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Tillman Road from +/-400 L.F. East of Hanna Street to North Phoenix Parkway by constructing new sidewalk on the south side, where no sidewalk currently exists. The project will provide a concrete sidewalk connection to Southtown Centre from the parks and trails to the west. This project will also include stormwater structure adjustments, seed, mulch, and restoration.
