The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

This project will include the cutting down of the trees in the City ROW affecting the 50/50, Misc. ROW Package and any other Public Works project in the Right of Way. These trees are being bid out by unit cost per the diameter of the tree. This will include the removal and grinding of the tree 8" below grade including the chipping and hauling of the tree

all in accordance with the Bidding Documents as prepared by **Transportation Engineering Services** for the City of Fort Wayne, Indiana.

No bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City.
