The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Improve three alleys between Milan St, E Pontiac St, Winter St, and S Anthony Blvd by removal of the existing concrete/ stone alley and alley approaches. Construction of new concrete alley, concrete alley approaches, replacement of castings, installation of new catch basin, installation of new storm pipe, tree removal and restoration of disturbed areas
