The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

**Improve the Winterfield Community Association neighborhood by removal and replacement of deteriorated concrete streets. Also, sidewalks and drive approaches will be reconstructed on an as necessary basis and new ADA compliant curb ramps will be constructed. New storm sewer infrastructure as well as subsurface drainage will be installed and adjustment of existing castings. Finally, restoration of disturbed areas**
