The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Improve the concrete Alley from Senate Ave. to South of McKinnie Ave. between Bowser Ave. and Holton Ave., by removing and replacing the existing concrete alley, reconstructing alley drive approaches and restoration.
