The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Improve the alley between Eliza St, Hayden St, McCulloch St, and Ohio St by the removal and replacement of the existing concrete alley, west alley approach and minimal sidewalk. This project will also include replacement of the older style castings and restoration of disturbed area.
