The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

Improve the concrete alley between Killea St, W Wildwood Ave, S Calhoun St, and S Harrison St by removing the deteriorated concrete alley and placing a new inverted concrete alley, with new concrete approaches and sidewalk

all in accordance with the Bidding Documents and Drawing No. ST- **0543D** as prepared by **Transportation Engineering** for the City of Fort Wayne, Indiana.
