The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, NWPZ Clinton: Wallen to Diebold Water Main Extension as follows:

Installation of approximately 4,200 lf of HDPE watermain via horizontal directional drilling through easements and under I-469. Project includes a mix of 16-inch and 12-inch pipe along with all required appurtenances required for a complete project.

all in accordance with the Bidding Documents as prepared by City Utilities, Fort Wayne, Indiana.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.
