Bids submitted shall be publicly displayed at the Board of Public Works, 200 E. The funding source for this project is Water SRF.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, White Oak Tank as follows:

Construction of a 500,000-gallon multi-leg elevated water storage tank, with connection to a 24" diameter watermain and an overflow connection to a storm sewer, including all associated pipe, valves, and other appurtenances.

all in accordance with the Bidding Documents as prepared by City Utilities Engineering.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.
