The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Filter Underdrain Replacement - Filters 22, 24, 25, 26, 27, 28 as follows:

General construction and mechanical work to install a new underdrain system in Filtration Plant Filters 22, 24, 25, 26, 27, and 28. Demolition of existing filter underdrain system and installation of associated low pressure air piping and acid wash system piping including control valves and instrumentation are also included in this project.
