The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Till Road Septic Elimination Project as follows:

**Install approximately 2,663 LF of 3" HDPE force main, 3064 LF of 1.5" HDPE force main, and 15 grinder pump stations east of Dawson's Creek and west of Coldwater Rd.**
