NOTICE is hereby given by the Board of Public Works of the City of Fort Wayne, Indiana, that sealed Bids for:

WATER POLLUTION CONTROL PLANT DIGESTER FEED & WITHDRAWAL PIPING IMPROVEMENTS CONTRACT/RESOLUTION NUMBER 76580

will ONLY be received by the Board of Public Works through its online bidding partner QuestCDN at www.questcdn.com. until 2:00 p.m. local time, **on February 6, 2020**. Bids submitted shall be publicly opened at the Board of Public Works, 200 E. Berry Street, Suite 210, conference room 220 Fort Wayne, IN 46802 immediately following and posted for viewing at www.questcdn.com.

The funding source for this project is State Revolving Fund (SRF).

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, WATER POLLUTION CONTROL PLANT, DIGESTER FEED & WITHDRAWAL PIPING IMPROVEMENTS as follows:

1. New Thickened Activated Sludge (TAS) force main including provision of:
 - a. Inside exposed ductile iron piping and valves
 - b. Buried HDPE piping – open cut and horizontal directionally drilled (HDD) construction
 - c. Precast concrete structure with HDPE pipe, ductile iron flange, valves and appurtenances
2. New Digested Sludge (DS) force main including provision of:
 - a. Inside exposed ductile iron piping and valves
 - b. Buried HDPE and restrained joint ductile iron piping – open cut and jack-and-bore construction
 - c. Cast-in-place concrete structures with ductile iron pipe, valves, and associated appurtenances
3. New W3 piping to the Digested Sludge Pump Station including provision of:
 - a. Inside exposed ductile iron piping and valves
 - b. Electrically actuated fabricated slide gate
 - c. Buried HDPE piping – open cut construction
4. New flushing water system if Owner accepts Alternate 1 including provision of:
 - a. Inside exposed ductile iron piping and valves
 - b. Variable frequency driven, horizontal split-case pump
 - c. Associated process instrumentation and control Work, electrical Work, and other Work

all in accordance with the Bidding Documents as prepared by Donohue & Associates, Inc. in association with ARCADIS U.S., Inc.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.
