The funding source for this project is Sewer State Revolving Funds.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Water Pollution Control Plant Laboratory Improvements as follows:

Construction of a new, approximately 3000 sqft, laboratory space inside existing building. New laboratory will be suspended in open space with new electrical, mechanical, plumbing, and network systems. Space include samples receiving area, storage space, seven test bays, new fume hoods, conference room, and furnishings for space.
