The funding source for this project is Sewer SRF Bond.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Superior Street Utility Improvements, Calhoun Street to Barr Street as follows:

**This project will include the construction of 820 linear feet of 36-inch to 48-inch consolidation sewer, five structures including two sanitary diversion structures, water main installation including 450 linear feet of 8-inch water main, 335 linear feet of 16-inch water main, and necessary water appurtenances, modifications to existing sanitary structures, and final roadway restoration. This project is the third phase of the Superior Street consolidation sewer work. The consolidation sewer will collect sewage from CSO 029 and transport flows back to the tunnel and eventually the Water Pollution Control Plant.**
