The funding source for this project is Sewer SRF Loan.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Thorngate Force Main as follows:

installation of approximately 5,085 LF of 12" HDPE sanitary sewer force main via Horizontal Directional Drilling

all in accordance with the Bidding Documents as prepared by City of Fort Wayne - Utilities Engineering Department.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.
