### **Steeplechase Lift Station Elimination CONTRACT/RESOLUTION NUMBER 76914**

Bids submitted shall be publicly displayed at the Board of Public Works, 200 E. The funding source for this project is Sewer State Revolving Fund.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Steeplechase Lift Station Elimination as follows:

#### **Construction of approximately 4,486 LF of 15" PVC gravity sewer and elimination of an existing lift station**

all in accordance with the Bidding Documents as prepared by the City Utilities Engineering Department, City of Fort Wayne, IN.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.

A Pre-Bid Conference will be held on 1/9/2023 at 11:00a local time at the Citizens Square Room 255 200E Berry Street Fort Wayne, IN 46802 to familiarize prospective bidders with the proposed project and to answer any questions. There will also be an online meeting at the same time with meeting details provided through Quest. Prospective Bidders may attend in person, or the online meeting.
