Bids submitted shall be publicly displayed at the Board of Public Works, 200 E. The funding source for this project is State Revolving Fund.

The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, 3RPORT - Tunnel Power and Control as follows:

The installation of low voltage power panels, controls panels, structures, and interconnecting conductors at seven (7) locations along the 3RPORT system.

all in accordance with the Bidding Documents as prepared by the City Utilities Engineering Department, City of Fort Wayne, Indiana.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.

A Pre-Bid Conference will be held on 5/20/2024 at 10:00:00 AM local time at the 200 E. Berry St, Suite 250, Room 255 to familiarize prospective bidders with the proposed project and to answer any questions. There will also be an online meeting at the same time with the meeting details provided through Quest. Prospective bidders may attend in person, or the online meeting.
