5. Approval of Amendment #3 Professional Services Agreement between the City of Fort Wayne and MLS Engineering for Resolution #76594, 7900-8500 Block Flutter Road Septic Elimination. Compensation for services performed shall be increased by \$2,520.00, bringing the total fee to \$18,170.00.
