The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Vesey Neighborhood-Quimby Village Stormwater Improvements as follows:

THE PROJECT INCLUDES THE INSTALLATION OF APPROXIMATELY 1,500 LF OF STORM SEWER RANGING IN SIZE FROM 12 INCH TO 30 INCH, 13 STORM STRUCTURES, AND MODIFICATIONS TO EXISTING STORM STRUCTURES. A NEW PUMP STATION INCLUDING A CAST-IN-PLACE CONCRETE STRUCTURE, PUMPS, VALVES, FITTINGS, AND PIPING WILL ALSO BE INSTALLED WITH THIS PROJECT.
