The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Ardmore Avenue & Airport Expressway Phase III Stormwater Improvements as follows:

**Installation of approximately 1,700 LF of storm sewers and culverts ranging in size from 12" – 48" in diameter, 1,500 LF of elliptical and box pipes ranging in size from 30"x19" up to 10' x 5', 1,800 LF of 6" underdrain, 9 structures, 15 end sections, appurtenances, grading an approximate 700 LF two-stage ditch channel, improvements to existing roadside ditches and swales in the project area, and final restoration of the site.**

all in accordance with the Bidding Documents as prepared by City Utilities Engineering Department, City of Fort Wayne, Indiana.

No Bid will be accepted from, or contract awarded to any person, firm, or corporation that is in arrears to the City of Fort Wayne, Indiana, upon any debt or contract, or, who has failed to execute, in whole or in part in a satisfactory manner, any contract with the City; or, who is a defaulter as to surety or otherwise, upon any obligation to the City, or is engaged in litigation with the City.
