The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Flaugh Road Sanitary Sewer Extension as follows:

Installation of approximately 3530 LF of 15" PVC (SDR 35) gravity sanitary sewer including 230LF of Jack and Bore under US 30.
