The Contractor shall furnish all labor, insurance, equipment, materials and power for the complete performance of the following project, Pettit-Rudisill Neighborhood Sewer Open Cuts as follows:

The open cut excavation replacement of two areas of combination sewer that are fully deteriorated in the Pettit-Rudisill Neighborhood. The replacement includes approximately 1,800 linear feet of 12" sewers, 7 manholes, and 5 catchbasins.
