**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL**

**SECTION 1.** That the CONSTRUCTION CONTRACT FOR ROTHMAN AREA CIPP I/I REMOVAL - RES. #2307-2010, W.O. #75472 by and between INSITUFORM TECHNOLOGIES USA and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for rehabilitation of entire collection systems in several neighborhoods by means of cured-in-place pipe (CIPP). The lining is for the reduction of inflow and infiltration into the existing system. Sizes range from 8" to 12". There is approximately 14,410 linear feet of 8", 920 linear feet of 10" and 2,595 linear feet of 12" that shall be lined. There are 7 cleanout structures that must be replaced with manhole structures prior to lining:

**AN ORDINANCE amending the Thoroughfare  
Plan of the City Comprehensive ("Master")  
Plan by vacating public right-of-way.**

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of Fort Wayne, Indiana, more specifically described as follows, to-wit:

The fifty-foot wide right-of-way of Woodway Drive, located between Lots 189 and 190 of Royal Oak Park Addition, Section B, as recorded in Deed Book 23, page 20 in the Office of the Recorder, Allen County, Indiana, more particularly described as follows:
