AN ORDINANCE TO APPROVE THE PURCHASE OF FORT WAYNE FIRE DEPARTMENT'S 800 MHZ RADIOS.

WHEREAS; The current 800 MHz radio system is reaching the end of its life cycle and efforts are underway to upgrade the system to be compatible with the new P-25 800 MHz radio intercommunication system; and

WHEREAS; replacement and/or software upgrades to the current radios used by both the City and County Fire Departments is necessary in order to be compatible with the new P-25 800 MHz radio system; and

WHEREAS; the City of Fort Wayne Fire Department has partnered with all other Allen County Fire Departments in applying for a grant to the Federal Emergency Management Agency (FEMA) through Assistance to Firefighters Grant Program (AFG) to assist in the purchase cost of the radio replacements or radio upgrades; and

WHEREAS; Fort Wayne's portion of the regional grant award is Nine Hundred Thousand, Three Hundred Twenty-Five and 00/100 Dollars (\$900,325.00). Other County fire departments portion of the grant will equal Four Hundred Eighty-Five Thousand, Four Hundred Twenty and 00/100 Dollars (\$485,420.00) with the total amount of the regional grant being One Million, Three Hundred Eighty-Five Thousand, Seven Hundred Forty-Five Dollars (\$1,385,745.00); and

WHEREAS; Fort Wayne Fire Department's matching portion for the grant is twenty-seven point ninety-nine percent (27.99%) which is Two Hundred Fifty-Two Thousand and 97/100 Dollars (\$252,000.97) with the federal government assuming the difference;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for Milling pavement surface and resurfacing pavement: pavement markings, adjust castings and valve boxes to grade in the 4th, 5th and 6th Districts:

involving a total cost of SIX HUNDRED EIGHTY-EIGHT THOUSAND, EIGHT HUNDRED NINETY-NINE AND 00/100 DOLLARS - (\$688,899.00). A copy said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.
