MATERNITY LEAVE CHANGES

As of January 1, 2017 all full-time, female employees who take time off following the birth of a baby will be provided six weeks of paid leave. The City will coordinate with the benefits available under the Short Term Disability plan to provide the employee 100% of their base salary without having to use their own sick, personal or vacation time. Any time taken after the 6 week period will be subject to the normal provisions currently in place. (Benefits for sworn police and fire personnel remain the same.)

BENEFITS FOR BARIATRIC SURGERY ADDED TO PLAN

Gastric bypass or other approved weight loss surgery will be added as a benefit effective January 1, 2017 with a \$25,000 lifetime maximum (including complications). Individuals may qualify if:

- Body Mass Index (BMI) is 40 or higher (extreme obesity)
- BMI is 35 or higher and you have a serious weight related health problem such as diabetes, high blood pressure or severe sleep apnea
- Efforts to lose weight with diet and exercise have been unsuccessful

Other provisions may apply

2017 PLAN OPTIONS

We will now be offering two health plan options. You can choose from the \$1200 deductible option which is a traditional plan OR the \$3400 deductible which is a high deductible plan with a Health Savings Account option. For more details including the rates for 2017, go to the Benefits website.



As a reminder, Flu Shots, Shingles Shots and Pneumonia Shots can be obtained through the pharmacy and paid at 100%

PLEASE NOTE:

The IRS is expected to announce an increase to the Flexible Spending Account annual limit for medical to \$2,600. If this change is not approved by the IRS the annual maximum will remain \$2,550.
