

City Revenue Analysis (in millions)





Local Income Tax (LIT) – Economic Development Distribution to City (formerly CEDIT)








2019 Property Tax/PS LOIT Expenses by Series

- Assessed Value growth 5 years in a row
- Fire and Police at full TARGET staffing
- Levy growth of 3.4%
- Streets & Roads spending of \$23.1 million

- Parks project work funded @ \$3.0 million
