

#### City Revenue Analysis (in millions)





## Local Income Tax (LIT) – Economic Development Distribution to City (formerly CEDIT)









#### Fiscal Notes



- Assessed Value growth 10 years in a row
- Fire and Police at full TARGET staffing
- Levy growth of 5%
- Income Tax revenue growth 8.3%
- Streets & Roads spending of \$37.1 million
- Trails funded at \$2.4 million
- Sidewalks & Alleys spending of \$6.4 million
- Bridge spending of \$2.4 million
- Parks capital work funded at \$3.0 million
- Parks bond issue \$10 million for Franke Park Renaissance plan
- City maintains a strong financial position
